## NOTICE OF IMPORTANT INFORMATION AND HEALTH WARNINGS

You must read the section below carefully and completely.

We are pleased that you are going to participate in the Biodanza World Encounter on Bali from February 24<sup>th</sup> until February 29<sup>th</sup> 2020 (the "Encounter"), organised by Enjoy Yourself, Inspire Others B.V., its facilitators, staff, volunteers and other people who assist and support in the Biodanza World Encounter (the "Encounter Organisation").

Many people have found a Biodanza Encounter to be an enjoyable and valuable experience. However, the Encounter is not advisable for everyone. The purpose of this notice is to ensure that you are not one of the people for whom this Encounter may be inadvisable.

We take our responsibility and your safety seriously. Although the number of people who have experienced serious problems during or after a Biodanza Encounter is quite small, you should be certain whether the Encounter is appropriate for you. If you have any questions, please contact a (mental) health professional. You declare with your registration for the Encounter that you have a full understanding of each and every paragraph which follows and that you understand our recommendations and will comply with our instructions.

The Encounter is designed for people who clearly understand they are responsible for their own health and well-being before, during and after the Encounter. It is not to be used as a substitute for medical treatment, psychotherapy or health program of any nature, regardless of what you may believe or have heard from anyone. We advise you that the Encounter Organisation with the facilitators, staff and other people who assist at the Encounter are not (mental) health professionals and that there will not be any (mental) health professionals in attendance.

If you experience any symptoms or suggestion of mental distress during the Encounter sessions, during the breaks or at the end of any session, or between sessions, you must immediately inform the Encounter Organisation. In such event, you and the Encounter Organisation will discuss the matter and you will determine

what is the appropriate thing for you to do. If you experience any symptoms or suggestions of mental distress, we strongly recommend that you immediately inform a physician or (mental) health professional.

If you have not been feeling well or if you have been meaning to see a physician or a (mental) health professional for some complaint, symptom or concern, or if you have had difficulty sleeping lately, or been depressed, it is imperative that you consult with a physician or (mental) health professional prior to your participating in the Encounter.

## CONFIDENTIALITY

In order to promote and respect the confidentiality of our participants and the intellectual property of all facilitators, please read and agree on the following:

I understand that the Encounter is limited to people who have registered in the Encounter. In consideration of, and as a condition for, permitting my participation in the Encounter, I represent, covenant, warrant and agree that:

- (a) I have registered in the Encounter under my own name for the sole purpose of participating in the Encounter;
- (b) I will not publish, broadcast or disclose or assist another person or organization in publishing, broadcasting or disclosing the identity, likeness or actual or paraphrased comments, of other participants in the Encounter, staff or other people who assist during the Encounter; and
- (c) I will not film, videotape, audiotape or otherwise record, by electronic, digital or any other means, all or any portion of the Encounter, and I will not record or take pictures, or assist another person or organization in recording and/or taking pictures of any kind or nature, of all or any portion of the Encounter or of any participants in the Encounter, facilitators, staff or people who assist in the Encounter. I will not take into the Encounter room a tape or video recorder, movie or still camera, or any device, electronic or otherwise, intended to record the voice or likeness of any person during the Encounter, except for your own personal private use.

## **Tickets**

- 1. A non-refundable payment for the amount of the Encounter attendance is required to secure all bookings.
- 2. Tickets can be given or sold to an alternate participant on the condition that the full name and email address is sent by the alternate participant to mail@biodanzaworld.com latest by February 24th, 2020. By sending this email the alternate participant agrees to these terms and conditions of the Encounter.
- 3. The Encounter Organisation has the right to alter or vary the programme for the Encounter or to reschedule or cancel all or part of the Encounter.
- 4. In the event of cancellation or rescheduling for whatever reason, the Encounter Organisation shall not be liable for any losses you suffer as a result of the cancellation or rescheduling, including but not limited to, accommodation costs or travel expenses.
- 5. Once purchased, tickets cannot be refunded or returned unless the event is cancelled or moved to another date on initiative of the Encounter

Organisation. Tickets will not be refunded for trip delay, trip cancellation, trip interruption caused by force majeure events like, but not limited to:

- a. Serious conflicts (molest).
- b. Armed conflict. A conflict between states or organized groups using weapons. Also actions of the United Nations peacekeeping force.
- c. Civil war. A more or less organized battle between residents of a country in which a large part of the inhabitants participate.
- d. Rebellion. Organized resistance with violence against public authority.
- e. Domestic riots. More or less organized violent actions at various places in a country.
- f. Riot. A more or less violent action against the public authorities.
- g. Mutiny. A more or less organized violent action of members of a group against their leaders.
- h. An atomic nucleus reaction. Or damage associated with an atomic nuclear reaction.
- i. Natural disasters or imminent natural disasters (such as floods, tsunamis, earthquakes, volcanic eruptions, storms and fire)
- j. Strikes or threatening strikes by carriers such as airlines.
- k. Terrorism: an incident or terrorism event be committed by a person acting alone or in association with other persons on behalf of or in connection with any organization of foreign government which is generally recognized as having the intent to overthrow or influence the control of any other foreign government.
- l. Epidemics.
- m. Severe changes in international and/or national political or social situations.

All costs, damages and effects caused by the occurrences as described herein are not covered by the Encounter Organisation and participants should ensure they have adequate insurance.

- 6. The Encounter Organisation and all other people who assist and support, cannot be responsible for (mental) healthcare, dental and ambulance services during the Encounter. The Encounter Organisation strongly recommends that participants take out comprehensive medical and travel insurance. Therefore, the Encounter Organisation and its co-organisers accept no responsibility of any nature whatsoever any damage including but not limited to personal injury, death, loss or damage to property or participants, however caused or arising.
- 7. Neither the venue nor the Encounter Organisation has any responsibility for lost or stolen property.
- 8. The Encounter Organisation or the venue has the right to refuse entry to the Encounter to any person without any reason or to require them to cease participating in any activity. If you are found to be behaving in a manner deemed unsociable or potentially dangerous, in breach of these terms & conditions, the rules and regulations of the venue or any instructions or directions given to you by any official at the Encounter, you will be ejected from the Encounter without refund and, if appropriate, may be reported to the police.

- 9. The Encounter Organisation and/or the venue has the right to search all persons and personal property and refuse admission to, or eject from, the site any person who refuses to be searched.
- 10. Admission to the venue and the Encounter is at your own risk. Neither the venue nor the Encounter Organisation will be held liable for any loss, cost, expense, injury or damage sustained at the venue and/or the Encounter.
- 11. You will abide by the rules and regulations of the venue which are available at the venue and may be changed at the venue's discretion and any other rules or regulations which may be included in the Encounter ticket.
- 12. The following articles are not permitted within the venue: illegal substances, drugs, weapons, dangerous or hazardous items, political or offensive materials, petrol generators, BBQ's or any other fire equipment and such other items as the Encounter Organisation or the venue may deem to be prohibited from time to time. Any person found in possession of such items may be refused entry into, or ejected from the venue.
- 13. The Encounter Organisation occasionally uses stills and footage of Encounter for marketing purposes. In taking part, participants agree to grant the Encounter Organisation a royalty-free, non-exclusive license to publish and otherwise use the material in any media worldwide, unless a written objection is sent to mail@biodanzaworld.com by February 24th, 2020.
- 14. These terms and conditions shall be governed by Dutch law exclusively and you submit to the exclusive jurisdiction of the Dutch courts.
- 15. The Encounter Organisation reserves the right to alter or amend these terms and conditions by notification to you. You will abide by such amended terms and conditions.
